In Colorado, rising blood alcohol is not as strong a defense when the charge against you is DUI per se or UDD. This is because these crimes are based solely on BAC as measured at the time you

How to Get Out of a DUI in Colorado - Top 20 Defenses

Colorado's "per se" blood alcohol content (BAC) is 0.08%, meaning that as long as a driver has a .08% BAC, he or she could be convicted of a DUI absent any other evidence of impairment.

Colorado also has what is known as an "aggravated DUI" charge, which permits enhanced penalties if the driver has a BAC of 0.17% or higher.
