To request a criminal history evaluation letter, an individual must: submit a request form, complete a criminal history questionnaire for each crime for which he or she was convicted or placed on deferred adjudication, and. pay a fee (\$25.00). When a complete request is received, the Department will review the requestor's criminal convictions, deferred adjudications, and any other aspect of his or her criminal history that may have bearing on a license application.
